Text is formatted as "Richtext" so you can control the font, SiZe, color, and <u>style</u>. You can bold, italic, and <u>underline</u>.

You can center text.

You can left justify.

You can right justify.

You can create and store completely different footnotes for standard investment reports, rate of return reports, insurance reports, standard contact management reports, new business reports and insurance commission reports.

Footnotes can be any number of pages you might need. Usually your Compliance Department will provide actual text. There is extensive help in our help topic on doing footnotes.
